New **SPOUSE** (age 18 and older) Club Membership is **\$50.00**, which includes the annual membership fee (\$50.00), plus the initiation fee (\$0.00). **Must include the name of the GTGC member who is your spouse.**

New **DISABLED VETERAN – SERVICE CONNECTED** Club Membership is **\$150.00**, which includes the annual membership fee (\$75.00), plus the initiation fee (\$75.00). **Proof of service-connected disability required.**

Dues for New Memberships shall be prorated as follows (call us for clarification if this is confusing):

- All new applications will pay the full Initiation Fee, as listed for their type of membership.
- Applications postmarked between September 1 and November 30 shall pay the full yearly dues.
- Applications postmarked between December 1 and February 28/29 shall pay 75% of the full yearly dues.
- Applications postmarked between March 1 and May 31 shall pay 50% of the full yearly dues.
- Applications postmarked between June 1 and August 31 shall pay 25% of the full yearly dues.

**NOTES:**

New member applications are normally processed within 2 weeks but may require up to 30 days for us to complete the background check. If membership is not approved, your check will be returned to you.

The annual membership renewal date, and corresponding gate code change, is September 1<sup>st</sup> of each year. A new initiation fee may be assessed for delinquent annual renewals received after October 31<sup>st</sup>.
